## CORPORATE GOVERNANCE STATEMENT 2020

This Corporate Governance Statement is current as at 29 September 2020 and has been approved by the Board of the Company on that date.

The Directors of Odin Metals Limited (the Company) and its controlled entities (the Group) are committed to achieving and demonstrating robust corporate governance practices which are appropriate for the Group's size and stage of development and which facilitate the long-term performance and sustainability of the Company as well as protecting and enhancing the interests of its shareholders. The Board guides and monitors the business and affairs of the Group on behalf of the Company's shareholders by whom they are elected and to whom they are accountable. The Board regularly reviews its governance practices to ensure they remain consistent with the needs of the Group. In addition, the Group monitors developments in governance market practice, expectations and regulations.

The Group complies with the majority of the recommendations set out in the Australian Securities Exchange ("ASX") Corporate Governance Council's Corporate Governance Principles and Recommendations 3rd Edition (the "ASX Principles"). This statement incorporates the disclosures required by the ASX Principles under the headings of the eight core principles. All of these practices, unless otherwise stated, were in place for the entire 2020 financial year and remain in place.

The 4th edition of the ASX Corporate Governance Council's Corporate Governance Principles and Recommendations is effective for the first full financial year commencing on or after 1 January 2020. Accordingly, the Company will be reporting against the 4th edition for its financial year ended 30 June 2021.
